# **HOW TO GET EIC?**



The EIC is the energy identification code of the natural gas market entities and/or the commercial metering point determined by the rules of the European Network of Transmission System Operators for Gas (ENTSOG), which is assigned in order to unify and uniquely identify natural gas market entities and commercial metering points installed on units of gas infrastructure, to participate in regional (international) gas markets, and to ensure simplification of procedures of natural gas supplier change and electronic data exchange between the natural gas market entitiesnht

### **INSTRUCTION**

### **Annual capacity:**

- » working volume
- » bundled capacity

Capacity is booked from the last Monday of January - 2<sup>nd</sup> Monday of February
Available for booking for a period of 1-4 years

### **Season capacity:**

- » working volume
- » injection
- » withdrawal

<u>Capacity booking for the injection season</u>: last Monday of January - 2<sup>nd</sup> Monday of February

<u>For the withdrawal season</u>: last Monday of July - 2<sup>nd</sup>

Monday of August

### **Monthly capacity:**

- » working volume
- » injection
- » withdrawal

<u>Capacity is booked</u> from 1<sup>st</sup> Monday - 3<sup>rd</sup> Monday of M for M+1 and until the end of the storage year

\* submit nomination until 3 pm D-1 for gas day D

### **Daily capacity:**

- » working volume
- » injection
- » withdrawal

<u>Day-ahead service = nomination/trade</u> <u>notification</u> payment no later than the end of the banking day D-2 (prior to the day of service provision)



# **CUSTOMS WAREHOUSE SERVICES**





To start gas storage activities in terms of customs warehouse, the following agreements shall be concluded with the SSO:

- 1. Natural gas storage (injection/withdrawal) agreement (hereinafter storage agreement)
- 2. Agreement for provision of services for customs declaration of natural gas transported across the customs border of Ukraine (hereinafter declaration agreement):
  - » Application for the agreement conclusion
  - » Originals of the agreement in 2 copies, filled out, signed by the customer and sealed (if any)

A transportation agreement shall also be concluded with GTSOU (Gas TSO of Ukraine)

Declaration agreement and storage agreement are concluded as per the same procedure. Completed documents on the part of the Customer shall be send to:

Periodic customs declaration (IM 74 PP)

Additional customs declaration (IM 74 ДР)

is the intention of the Customer of storage services to place a certain amount of natural gas in the CW for a certain period from 1 day to 180 days

CUSTOMS WAREHOUSE is the evidence of actual volume of natural gas placed in the CW with a storage period of up to 1095 days and a possibility of the Customer storage services in part transfer of volumes to other entities

Periodic customs declaration (EK 11 PP) Re-export

is the intention of the Customer of storage services to re-export a certain amount of natural gas from the customs territory of Ukraine, in particular the CW within a certain period from 1 day to 180 days


